**LAND DEVELOPMENT
CODE ENFORCEMENT/SURVEYS**

LAND USE REGULATIONS

The Green Lake County Zoning Ordinance shall apply in the Towns of Berlin, Brooklyn, Green Lake, Mackford, Manchester and Marquette. The Shoreland Protection Ordinance shall apply in all the Towns in Green Lake County.

A land use permit is required for construction and development activities in these areas and is valid for 1 year from the date of issuance.

“Shorelands” are defined as being: those lands lying within 1,000 feet of the ordinary high water mark of a lake, pond or flowage; and those lands lying within 300 feet of the ordinary high water mark of a river or stream or to the landward side of the floodplain, whichever distance is greater.

Additional information and applications for permits may be obtained from the Code Enforcement Office, Courthouse, Green Lake, Wisconsin from 8:00 AM to 4:30 PM Monday through Friday.
