The regular special meeting of the Highway Committee was called to order by Chair Eugene Henke at 9:00 AM on Wednesday, May 25, 2011. The requirements of the Open Meeting Law were certified as being met.

Agenda

Motion/second (Hedberg/Peters) to approve the Agenda. Motion Carried.

Appearances

Both Curtis and Chad Klatt, residents of the Town of Marquette still expressed concerns regarding getting their equipment in/out of the fields, and questioning the culvert placement as this would change the natural waterway. The way the water runs and sits in the ditch is a concern.

Robert Podgorski explained a new plan (map dated 5/13/11) drawn up by Ayres Associates) for a limited term easement for slopping which reduces the new right-of-way by approximately 700 SF.

Keith Nikolay explained the redesign of the intersection is in accordance with DOT Standards and their guidelines need to be followed and what Curtis and Chad Klatt want will not meet DOT Standards. Keith Nikolay stated that there would be no more design costs, but a new right-of-way plat and relocation order will need to be submitted to the Courthouse, the appraisal will be redone with the new right-of way as now the acreage has been reduced. The additional cost to the county would be approximately \$2,000.00.

Discussion was held. Curtis Klatt indicated that he had 20 days to accept the original Jurisdictional Offer. It was noted that Curtis Klatt rejected the Jurisdictional Offer and sent via registered mail to Carol Ahles of Steigerwaldt Land Services, Inc. Steigerwaldt Land Services, Inc. received on 5/17/11.


Due to the weather, the committee meeting was moved to the Town of Marquette Town Hall for further discussion at 9:48 am.

It was explained to Curtis and Chad Klatt that the jog will be taken out of the left side of the road, 700 SF less property will be taken away, and if all are in agreement with this new plan a new Jurisdictional Offer will need to be signed by both Curtis Klatt, and the Commissioner.

Motion/second (Peters/Hedberg) to approve the new plan (map) dated 5/13/11 with the limited term easement and the Jurisdiction Offer of May 5, 2011 for extending until June 10, 2011 to be signed by Robert Podgorski, Commissioner and Curtis Klatt. It is also noted that no extra commitments are or will be offered. Roll Call Vote (4) Ayes, (0) Nays, (1) Absent (Perr). Motion Carried.
