The following are the open minutes of the Quarterly Meeting of the Green Lake County Veterans Service Commission held in the Veterans Service Office at the Health and Human Services Center, Green Lake, WI, at 10:30 A.M. on April 5, 2010.

Beuthin reported that there will be no change in mileage reimbursement, it will continue to be the Federal rate. Per Diem will change to \$45.00 after the April Board meeting.

**Service Office Report:** Beuthin reported that for 2010 contacts were down 6%, mail was up 12% and VA hospital trips are down 16.5% compared to 2009.

Beuthin reported that he will be attending the WICVSOA Spring Conference in Green Bay the week of May 17-21. The Welcome Home to Vietnam veterans, LZ Lambeau, will the following weekend from May 21-23.

Beuthin reported that there were 14 veteran's deaths in the County since the beginning of the year.
