## 2012 BUDGETS

2012 Budgets by Emergency Government, Coroner, Child Support and Clerk of Courts were presented with the 3% reduction met.

District Attorney presented some options for his budget and how they could try to meet the 3% reduction. Collins would like to meet with Corporation Counsel before submitting his final budget to the Committee. Collins will bring his revised budget back to the Committee at the next regular meeting.

New elect Judge Mark Slate asked the Committee if the Family Court Commissioner and Circuit Court-Judge 2012 Budgets could be discussed after August 1<sup>st</sup>, when he takes office. Slate is looking at combining Family Court Commissioner and Circuit Courts budget.

Schubert made a recommendation that new elected Judge Mark Slate, Corporation Counsel and the Judicial Law Committee meet in closed session at the next regular meeting.

Sheriff Mark Podoll presented the Sheriff Department budget for 2012. Podoll stated that they made cuts to meet the 3% reduction but once you put the personnel cost in the budget they had a slight increase.

Also to have District Attorney, Family Court Commissioner and Circuit Courts revised budgets be presented at the next regular meeting on August 10<sup>th</sup>, 2011.
