Fair Committee Discussion – 2012 Fair

2013 DEMOLITION DERBY CONTRACT – DISCUSSION/APPROVAL

Zills presented the Committee with a Profit/Loss Statement and the Payout Form from Action Auto Promotions. This information was requested by the Committee before signing a contract with AAP for the 2013 Fair. The 2012 Contract included \$1,700 in prize money furnished by the Fair. The 2013 Contract requests \$2,200 be offered in prize money. The Committee would like an estimate of what prize money he put in in 2012. Motion to table this until December meeting when there is more information. *Motion/second (Reabe/Stoddard)* Motion carried.

TRUCK/TRACTOR PULL CONTRACT - DISCUSSION/APPROVAL

Zills contacted Corp. Counsel Sondalle regarding the insurance. The current contract states that Richard Swanke will supply a copy of Pullers Inc. and Luedtke's Eliminator Certificates of Insurance and Pullers Inc. will provide public liability insurance. Swanke will also look into getting his own insurance for the event. There was discussion regarding the beer profits. Motion to table it until Swanke comes back with a signed contract from the Legion that they will do it 60/40, and all profits go to the Fox River Patriots 4-H Club. *Motion/second (Reabe/Moderow)*. Motion carried.

2012 FAIR 10% REVENUE UPDATE - DISCUSSION

Zills gave the Committee the report of what is still out there.

2012 FAIR COMMUNITY INVOLVEMENT PROGRAM (CIP) REPORT – DISCUSSION

Zills reported this money is spent on the current fair year only. The Committee was asked to please look over the list and bring back in January.

YOUTH EXHIBIT COMMITTEE REQUEST/SWINE PENS - DISCUSSION

The Youth Exhibit Committee will meet the Wednesday of fair week for a Mandatory meeting of all youth that will be selling animals in the fair auction. The Livestock Committee is doing further research on the swine pens.

FAIR ENDOWMENT FUND - DISCUSSION

Zills reported the Fair has established a charitable endowment with the Oshkosh Area Community Foundation since 2009. The Green Lake County Fair Fund will support the future development of youth and the fair, along with general operations. Endowment funds are permanent charitable funds that provide long-term financial support.

WAF CONVENTION

Zills reported that the class list is not out yet, but will get it to the Committee if they are interested in going.

2013 COMMERCIAL SPACE PROCESS - DISCUSSION/APPROVAL

Zills reported that Magic Sweep called the day before the fair and could not come, but paid for it. So, she went ahead and accepted the Tastefully Simple consultant and now Tastefully Simple wants to come back, but Magic Sweep would like to as well. There was a motion to continue with Magic Sweep, since they were the initial person for that commercial space. *Motion/second (Stoddard/Reabe)*. Motion carried.
