2013 DEMOLITION DERBY CONTRACT - DISCUSSION/APPROVAL

Zills contacted Jerry at Action Auto Promotions and he would donate an extra \$100 and the fair will donate an extra \$400 for prize money. He did sign a 2 year contact for 2013 & 2014. There was discussion regarding the advertising of the extra prize money, if it is at our expense or at his expense. Zills will contact him regarding it. Motion was made to accept the contract. *Motion/second (Stoddard/Moderow)* Motion carried.

2013 TRUCK & TRACTOR PULL CONTRACTS - DISCUSSION

Zills provided the committee with the contracts and highlighted areas of difference. Swanke will be raising the gate fee to \$10, previously was \$8. 40% net profit to the fair, 60% to the Fox River Patriots 4-H Club. Regarding sale of food, Swanke needs

to follow the fair vendor policy and the fair can accept/reject certain food sales accordingly if a vendor is already selling that food. Zills will update the contract and provide it to the committee in January.

2013 FAIR COMMUNITY INVOLVEMENT PROGRAM (CIP) MAILING – DISCUSSION/APPROVAL

Zills asked if anyone had any changes to the brochure/flyer, and if so, to please give them to her after the meeting.

FAIR BARNS/ROOF REPAIRS - DISCUSSION

Zills and Reabe checked with Scott Weir regarding the roofs. The nails have backed out and need to be replaced with screws and they are looking at putting a coating on the roof to stop the rusting. Not all will be done this year because of budget. There is no structural damage. Swine pens are on hold, the Livestock Committee applied for a grant from Monsanto and Zills applied for \$1,000 grant from the Alfred Peck foundation in Green Lake.

HORSE ARENA CLEAN-UP - DISCUSSION

Zills and Moderow have not had any contact with Bob Kallio regarding the arena.

COMMITTEE DISCUSSION - REPORT OF LAST MONTH'S MEETING - INCLUDING Q&A

- a. <u>Property & Insurance Committee</u> Stoddard reported that Scott Weir requested the need of another man to keep up with the building. P&I approved it. The press of one button and Weir knows what the temps are in each room of the building.
- b. <u>Personnel Committee</u> Schweder reported on November 15 and 27 the Dept. of Human Services presented four resolutions that deleted a position, created positions and converted a position to meet the needs of the department. There was not any increase in the DHS budget as a result of the changes. Discussion concerning the Administrative Policy Manual and the Personnel and Procedures Manual.
- c. <u>Finance Committee</u> Reabe reported that it was approved to have Scott Weir get another person in his department. Still working on a number of people that are in arrear of their property taxes. In good with the 2013 budget.
