**Seneca-Warren Drainage District – Sucker Creek/Lateral A:** Hebbe reported that the DNR is required to obtain bids for the spraying project. The plan is still to conduct an August spraying of the ditch.

**Seneca-Warren Drainage District – Survey from Highway D to Fox River:** Survey to be done in August or September.

**Seneca-Warren Drainage District – Replace Culvert on County Road F:** *Motion/second (Krueger/Severson)* that Chairman Soda send a letter to the Waushara County Highway Department asking for the sizing and capacity of the replacement culvert on Highway F. Motion carried.

**Watershed Tax Assessment:** State Drainage Engineer Seth McClure explained the step-by-step procedure to determine and start the process of initiating a watershed tax assessment. *Motion/second (Severson/Krueger)* to send a request for bid costs to the mentioned firms (Resource Engineering Associates; Mark Madsen; and MSA Professional Services) to submit a cost estimate for conducting a watershed assessment study. Motion carried.

**Vouchers:** *Motion/second (Severson/Krueger)* to approve one \$40 voucher to Curran, Hollenbeck & Orton, SC for Sucker Creek issue legal fees for Seneca-Warren Drainage District. Motion carried.
