June 2017 Projects

1. Completed design for Grade Stabilization Structure (EQIP)
2. Design calculations for WASCOB Outlet extension and Underground Outlet.
3. Designs for Grass Waterway and Subsurface Drainage – 2 Landowners (LWRMP)
4. Completed plans for Heavy Use Protection and Roof Runoff Management (EQIP)
5. Webinars Attended: Soil Health on Urban Farms, Concrete Construction Inspection, De-nitrifying Bioreactors.
6. Complete the construction of a grade stabilization structure in the Town of Green Lake.
7. Complete the design for a grade stabilization structure with and underground outlet in the Town of Brooklyn.
8. Complete the final FPP checks for the group 1 spot check in the Green Lake watershed.
9. Meet multiple landowners to discuss projects that will cross multiple landowner property lines.
10. Begin conducting FPP inspections for spot check groups 1 and 2 in remainder of Green Lake County.
11. Multiple site showings with potential bidders for a grade stabilization structure in the Town of Green Lake.
12. Continue gathering data for Rock River TMDL.
13. Assisted landowner receiving sediment from adjacent house construction.
14. Assisted landowner with creek-crossing and driveway-in-state-ROW questions.
15. Assisted landowner with pond permits questions.
16. Assisted landowner with well abandonment cost-share application.
17. Conducted FPP Conservation Compliance Farm Checks.
18. Evaluated inquiries, complaints, land disturbance sites, land and conditional use permits, and rezone and variance approvals for CSEC&SWM permit applicability.
19. Forwarded Clean Sweep information to a customer.
20. Reviewed and discussed CSEC&SWM permit applications; issued and monitored permits.
21. Reviewed, discussed, organized, and notified landowner's Storm Water Mgmt. file.
22. Supplied soil & land conditions, limitations and other information to realtor.
23. Clean Sweep advertisement and registration is in full swing. Lots of phone calls and inquiries.

July 2017 Project Focus

1. Continue FPP inspections for group 1 and group 2 spot checks.
2. Continue work on Rock River TMDL project and run watersheds through STEPL tool.
3. Begin construction on grade stabilization structure and grassed waterway in the Town of Green Lake.
4. Complete the design for a full flow weir project in the Town of Brooklyn.
5. Continue inspections of the Animal Waste Storage facilities in Green Lake County.

Lake and River Report

Little Green – Attended meeting #2 and #3 with Little Green Lake Planning Committee and Lake Consultant.

Twin Lakes – Soil sampling is complete in the watershed. Very high level of participation. Only 1 ag producer did not participate.

Spring Lake - Soil sampling is complete in the watershed. Currently is being entered into the modeling software.

Lake Puckaway – No Update.

Green Lake - Update of lake management plan underway.

Grand Lake – Attended meeting #2 and #3 with Grand Lake Planning Committee and Lake Consultant.
