Please join us for this half-day workshop focusing on how we can better work with children who have experienced trauma and how to nurture children through the power of infant massage.

First, we will hear from a panel of three clinicians from Waushara County Human Services. All three speakers, **Dr. Toni Morgan-Jones, PH.D., Brianna Kulibert, LPC, and Jenny Ward, LCSW** have recently completed a year-long training specializing in trauma-focused cognitive behavioral therapy. They will share techniques and practical information for us to use in our daily work to better serve children experiencing trauma as well as grief.

Next, we will hear from **Donna Anderson, MS, PT, CEIM** on the power that infant massage has on nurturing young children and developing healthy relationships from the beginning. Donna has worked with young children and their families in hospitals, developmental centers, private practice, public schools, and early intervention programs for over 25 years. She has a passion for promoting nurturing touch and massage and is dedicated to a vision of a more peaceful and gentle world for all.
